
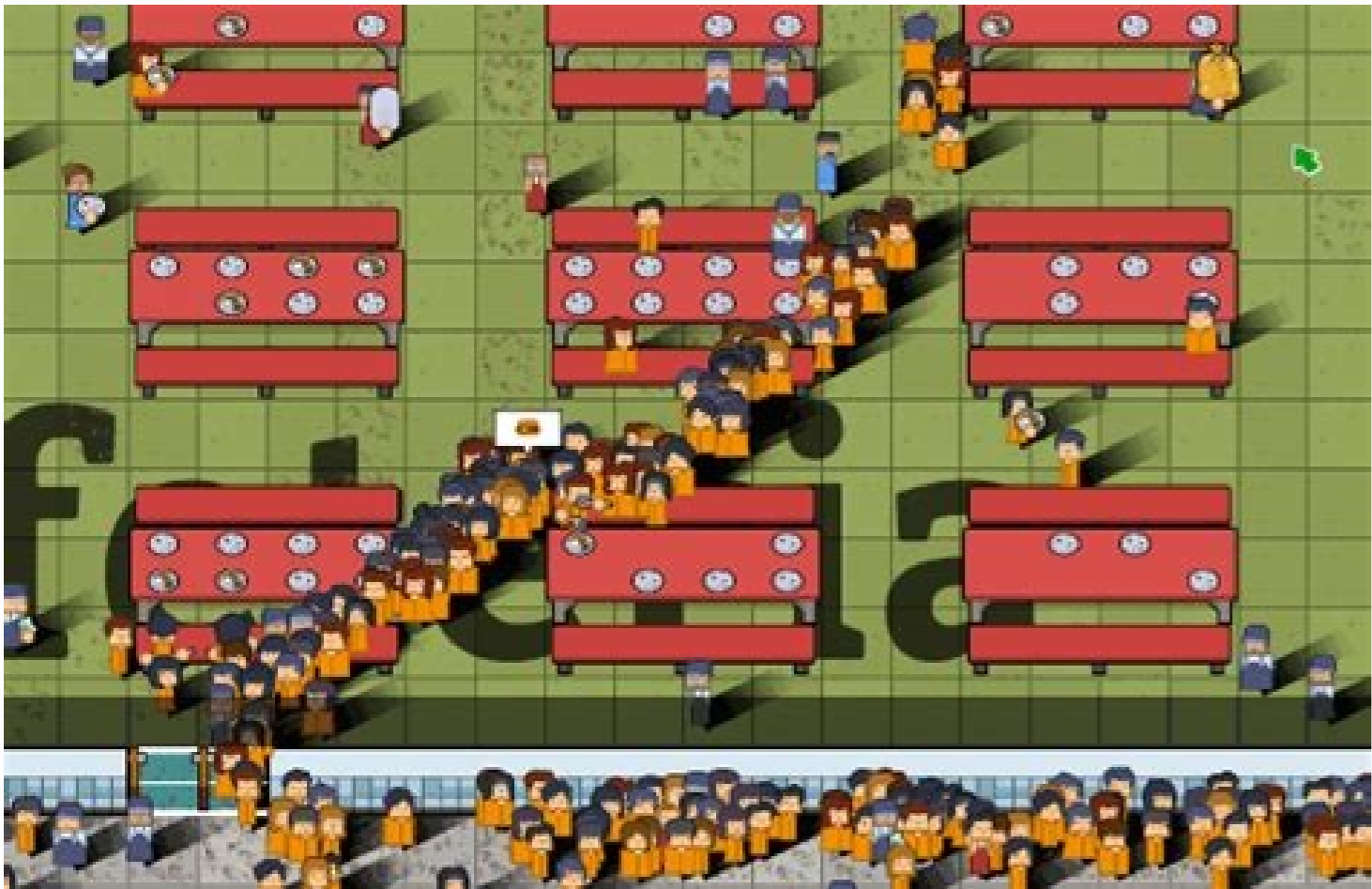
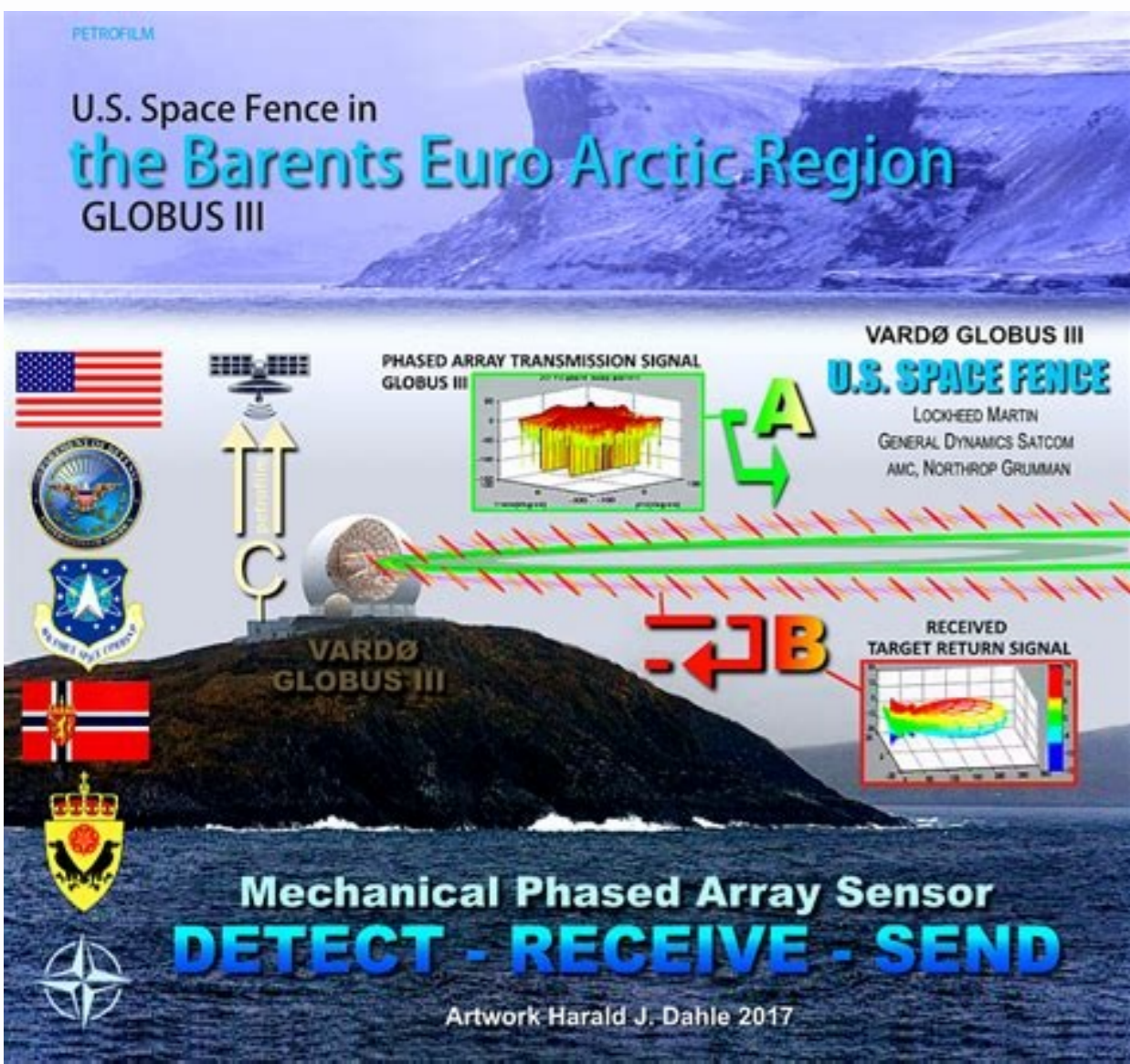

# Detention game guide

Multiple "critical incidents" need to be reviewed at ACT prison facilities. Photo: Archive. The annual report of the Inspector of Correctional Services of ACT has raised concerns about the levels of funding allocated, given the increased workload, the additional facilities for management and the major critical incidents to be considered after a shortage of problems in the prison. The opening statements of Inspector Neil McAllister in his 2020-21 report also highlighted issues with staffing levels each year. The role of the OIC is to promote the continuous improvement of ACT prisons and juvenile justice facilities. It has jurisdiction over the Alexander Maconochie Centre (AMC), the Tribunal Transport Unit and the Bimberi Youth Justice Centre. It is also responsible for examining critical incidents such as riots, fires and attacks at these facilities. Given the history of the AMC, the OICS has been occupied. In November 2020, a major riot in the prison caused \$5.7 million damage and, according to the OIC report, less than 10 per cent of prison staff received effective training to address major riots in 2020. This was followed by another revolt in May of this year, as well as an incident of hostage-taking. "In terms of the damage caused and the operational impact, these incidents were the most important that I have considered as Inspector so far," says Mr. McAllister. He subsequently made several recommendations for "preparation for organizational response". Mr. McAllister had determined that, although the initial decision to deprive the detainee had a legal basis, the use of force was not used as the last recourse and violates the rules. We have noted that conducting a forced search was not an approach with which all staff were completely comfortable". Mr. McAllister said earlier. The report recommended that the AMC end mandatory strip searches and acquire additional body scanners. According to its report, in the period 2020-21 there were seven "critical incidents" at the CMA, five of which required further review. But Mr. McAllister said in his report that his office was only funded to review one critical incident a year. "It is clear once again that this year the critical incident review functions are taking up more of my operating budget than originally planned", he said. His report also notes that his overall staffing has decreased slightly from year to year, even though he is still waiting for additional funding to take over the supervision of Bimberi. Mr. McAllister said he had previously pointed out as a problem that his "office was never funded to carry out the supervision of juvenile justice facilities." "If my office is designated as the MNP [National Preventive Mechanism] for adult and juvenile justice facilities, I'm concerned that we don't have enough funds to make our ASO6 position permanent", the report says. Instead, we funded this temporary position from our operating budget, which is far from ideal". This was the first year that the Board supervised Bimberi, so significant resources had also been allocated to carry out a major health review of the facility's prisons. One of the main concerns raised by the review was that children were in full view of their Security cameras while they were searched naked, showered or changed clothes The report contains 93 findings and 27 recommendations.
